## **I. 2019 Legislative Leaders Chosen**

The legislative leadership for the 66<sup>th</sup> Legislative Assembly has been chosen. Republican and Democratic House and Senate members have selected the following leaders for the 2019 legislative session. ## **II. Governor's Budget: General**

The Governor's Budget Recommendation priorities include infrastructure, tax relief, education and economic development. On December 5<sup>th</sup>, Governor Burgum presented the Executive Budget Recommendations to the Legislative Assembly, which included revenues totaling \$14.3 billion and \$14.3 billion in ongoing expenditures.

The [2019-2021 Revenue Forecast](#), along with Moody's Analytics' economic report, was presented by the Office of Management and Budget following the organizational session.

**III. Governor’s Budget: Water**

The initial Governor’s Budget Recommendation includes \$464 million for one “bucket” of essential water projects under the State water Commission, of this amount \$403 million would state funds for water project funding.

On December 7<sup>th</sup> the State Water Commission adopted a 2019-2021 funding priority list totaling \$478 million, which includes \$75 million of debt for the Northwest Area Water Supply project. The SWC priority list has many of the same project areas, but the targeted funding amounts differ from the project funding needs identified by the North Dakota Water Coalition for water project needs in 2019-2021 which total \$552.4 million which would entail \$150 million of credit:

April 30	Session is limited to 80 legislative days (The Legislature may not meet each day, which could extend this deadline)

Bills regarding restoration of cost-share for snagging and clearing, as well as adjustments to tile drainage permit processes, and extending the mill levy for Southwest Water Authority are anticipated to be

introduced in the 2019 session. As of this date, bills have not been introduced.
